- (a) Authorization. -- In accordance with the powers under 5
- section 503-A(a) and duties under section 503-A(c), the State 6
- 7 Inspector General may issue a subpoena relating to any matter
- 8 pertinent to an examination to a person under the State
- Inspector General's jurisdiction or to an individual or a person 9
- receiving services from or through an executive agency. If a 10
- person fails or refuses to obey a subpoena, the State Inspector 11
- General may petition a court of competent jurisdiction to enter 12
- an order compelling the witness to appear and testify or produce 13
- 14 documentary evidence. Failure to obey the court order shall be
- 15 punishable as contempt of court.
- 16 (b) Form and effect. -- A subpoena under subsection (a) shall 17
 - be in substantially the same form and have the same force and
- effect as a subpoena issued by a court of common pleas. The 18
- 19 State Inspector General shall have the benefit of the process of 20 the appropriate court of common pleas if necessary to enforce a
- 21 subpoena.

- (c) Confidentiality. -- A subpoena issued under this section
- 23 must clearly indicate on the face of the subpoena that the
- subpoena is issued in connection with a confidential proceeding 24 and a breach of confidentiality by the person subpoenaed may 25
- result in a civil penalty or misdemeanor. 26
 - (d) Fees. -- Witnesses subpoenaed under this section shall be compensated under 42 Pa.C.S. § 5903 (relating to compensation
- 29 and expenses of witnesses).
- 30 Section 506-A. Criminal charges.
 - Notwithstanding any other provision of law, the State
 - Inspector General shall have the power to investigate and may file criminal charges for a violation of any of the following:
 - (1) Section 481 of the act of June 13, 1967 (P.L.31,
