AN ACT

- Authorizing and directing the Department of General Services, with the approval of the Governor, to grant and convey to TCA
- 3 Properties, L.P., certain lands and improvements situate in
- 4 the City of Allentown and the City of Bethlehem, Lehigh
- 5 County.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Conveyance in the City of Allentown and the City of
- 9 Bethlehem, Lehigh County.
- 10 (a) Authorization. -- The Department of General Services, with
- 11 the approval of the Governor, is hereby authorized and directed
- 12 on behalf of the Commonwealth of Pennsylvania to grant and
- 13 convey, for fair market value, as established through an
- 14 independent appraisal, the following tracts of land together
- 15 with any buildings, structures or improvements thereon, situate
- 16 in the City of Allentown and the City of Bethlehem, Lehigh
- 17 County, to TCA Properties, L.P.
- 18 (b) Property description. -- The property to be conveyed

- 16 (c) Requirement for conveyance. -- The conveyance shall be
- 17 made under and subject to all lawful and enforceable easements,
- 18 servitudes and rights of others, including, but not confined to,
- 19 streets, roadways and rights of any telephone, telegraph, water,
- 20 electric, gas or pipeline companies, as well as under and
- 21 subject to any lawful and enforceable estates or tenancies
- 22 vested in third persons appearing of record, for any portion of
- 23 the land or improvements erected thereon.
- 24 (d) Gaming restriction. -- Any conveyance authorized under
- 25 this section shall be made under and subject to the condition,
- 26 which shall be contained in the deed of conveyance, that no
- 27 portion of the property conveyed shall be used as a licensed
- 28 facility, as defined in 4 Pa.C.S. § 1103 (relating to
- 29 definitions), or any other similar type of facility authorized
- 30 under State law. The condition shall be a covenant running with

- 1 the land and shall be binding upon the grantee, its successors
- 2 and assigns. Should the grantee, its successors or assigns
- 3 permit any portion of the property authorized to be conveyed in
- 4 this section to be used in violation of this subsection, the
- 5 title shall immediately revert to and revest in the grantor.
- 6 (e) Covenants, conditions and restrictions. -- The Secretary
- 7 of General Services may impose any covenants, conditions,
- 8 restrictions and reservations on the sale of the property as is
- 9 deemed in the best interests of the Commonwealth of
- 10 Pennsylvania.
- 11 (f) Easements. -- The Secretary of General Services may grant
- 12 or retain any easements necessary to effectuate this section.
- 13 (g) Deed of conveyance. -- The deed of conveyance shall be by
- 14 special warranty deed and shall be executed by the Secretary of
- 15 General Services in the name of the Commonwealth of
- 16 Pennsylvania.
- 17 (h) Costs and fees.--All costs and fees incurred by the
- 18 Department of General Services shall be borne by the grantee.
- 19 Section 2. Repeals.
- 20 Repeals are as follows:
- 21 (1) The General Assembly declares that the repeal under
- 22 paragraph (2) is necessary to effectuate section 1 of this
- 23 act.
- 24 (2) Section 4 of the act of July 9, 2013 (P.L.429,
- No.62), is repealed insofar as it is inconsistent with this
- 26 act.
- 27 Section 3. Effective date.
- 28 This act shall take effect in 60 days.
