## AN ACT

18	Section 1. Section 912.1 of the act of June 3, 1937 - <

21	SECTION 1. SECTIONS 908, 912.1 AND 951(C) OF THE ACT OF JUNE <
22	3, 1937 (P.L.1333, NO.320), KNOWN AS THE PENNSYLVANIA ELECTION
23	CODE, ARE AMENDED TO READ:
24	SECTION 908. MANNER OF SIGNING NOMINATION PETITIONS; TIME OF

CIRCULATING.--EACH SIGNER OF A NOMINATION PETITION SHALL SIGN 1 BUT ONE SUCH PETITION FOR EACH OFFICE TO BE FILLED, AND SHALL 2 DECLARE THEREIN THAT HE IS A REGISTERED AND ENROLLED MEMBER OF 3 4 THE PARTY DESIGNATED IN SUCH PETITION: PROVIDED, HOWEVER, THAT WHERE THERE ARE TO BE ELECTED TWO OR MORE PERSONS TO THE SAME 5 6 OFFICE, EACH SIGNER MAY SIGN PETITIONS FOR AS MANY CANDIDATES 7 FOR SUCH OFFICE AS, AND NO MORE THAN, HE COULD VOTE FOR AT THE SUCCEEDING ELECTION. HE SHALL ALSO DECLARE THEREIN THAT HE IS A 8 9 QUALIFIED ELECTOR OF THE COUNTY THEREIN NAMED, AND IN CASE THE NOMINATION IS NOT TO BE MADE OR CANDIDATES ARE NOT TO BE ELECTED 10 11 BY THE ELECTORS OF THE STATE AT LARGE, OF THE POLITICAL DISTRICT THEREIN NAMED, IN WHICH THE NOMINATION IS TO BE MADE OR THE 12 13 ELECTION IS TO BE HELD. HE SHALL ADD HIS [RESIDENCE] ADDRESS 14 WHERE HE IS DULY REGISTERED AND ENROLLED, GIVING CITY, BOROUGH OR TOWNSHIP, WITH STREET AND NUMBER, IF ANY, AND SHALL LEGIBLY 15 PRINT HIS NAME AND ADD THE DATE OF SIGNING, EXPRESSED IN WORDS 16 17 OR NUMBERS: PROVIDED, HOWEVER, THAT IF THE SAID POLITICAL 18 DISTRICT NAMED IN THE PETITION LIES WHOLLY WITHIN ANY CITY, 19 BOROUGH OR TOWNSHIP, OR IS COEXTENSIVE WITH SAME, IT SHALL NOT 20 BE NECESSARY FOR ANY SIGNER OF A NOMINATION PETITION TO STATE THEREIN THE CITY, BOROUGH OR TOWNSHIP OF HIS RESIDENCE. NO 21 NOMINATION PETITION SHALL BE CIRCULATED PRIOR TO THE THIRTEENTH 22 TUESDAY BEFORE THE PRIMARY, AND NO SIGNATURE SHALL BE COUNTED 23 24 UNLESS IT BEARS A DATE AFFIXED NOT EARLIER THAN THE THIRTEENTH TUESDAY NOR LATER THAN THE TENTH TUESDAY PRIOR TO THE PRIMARY. 25 26 Section 912.1. Number of Signers Required for Nomination 27 Petitions of Candidates at Primaries .-- Candidates for nomination 28 of offices as listed below shall present a nominating petition 29 containing at least as many valid signatures of registered and 30 enrolled members of the proper party as listed below:

(1) President of the United States: Two thousand.

2 (2) United States Senate: Two thousand.

3 (3) Governor: Two thousand including at least one hundred4 from each of at least ten counties.

5 (4) Lieutenant Governor: One thousand including at least one
6 hundred from each of at least five counties.

7 (5) Treasurer: One thousand including at least one hundred8 from each of at least five counties.

9 (6) Auditor General: One thousand including at least one10 hundred from each of at least five counties.

11 (7) Attorney General: One thousand including at least one 12 hundred from each of at least five counties.

13 (8) Justice of the Supreme Court: One thousand including at14 least one hundred from each of at least five counties.

15 (9) Judge of the Superior Court: One thousand including at 16 least one hundred from each of at least five counties.

17 (10) Judge of the Commonwealth Court: One thousand including18 at least one hundred from each of at least five counties.

19 (11) For any other office to be filled by the vote of the 20 electors of the State at large or for any other party office to 21 be elected by the electors of the State at large: One thousand 22 including at least one hundred from each of at least five 23 counties.

24 (12) Representative in Congress: One thousand.

25 (13) Senator in the General Assembly: Five hundred.

(14) Representative in the General Assembly: Three hundred.

(16) Public or party offices to be filled by a vote of the
electors in counties of the second class at large: Five hundred.

9 (20) Public or party offices to be filled by a vote of the 10 electors in counties of the fourth class at large: Two hundred 11 fifty.

12 (21) Public or party offices to be filled by a vote of the 13 electors in cities of the second class at large: Two hundred 14 fifty.

15 (22) Public or party offices to be filled by a vote of the 16 electors in cities of the second class A at large: One hundred. 17 (23) Public or party offices to be filled by a vote of the electors in cities of the third class at large: One hundred. 18 (24) Public or party offices to be filled by a vote of the 19 20 electors in counties of the fifth class at large: One hundred. 21 (25) Public or party offices to be filled by a vote of the 22 electors in counties of the sixth class at large: One hundred. 23 (26) Public or party offices to be filled by a vote of the electors in counties of the seventh class at large: One hundred. 24 25 (27) Public or party offices to be filled by a vote of the electors in counties of the eighth class at large: One hundred. 26 (28) Office of judge of any court of record other than a 27 28 Statewide court or a court in a county of the first or second 29 class: Two hundred fifty.

12 SECTION 951. NOMINATIONS BY POLITICAL BODIES.--\* \* \* <---13 (C) EACH PERSON SIGNING A NOMINATION PAPER SHALL DECLARE 14 THEREIN THAT HE IS A QUALIFIED ELECTOR OF THE STATE OR DISTRICT, 15 AS THE CASE MAY BE, AND SHALL ADD TO HIS SIGNATURE HIS LEGIBLY 16 PRINTED NAME AND [RESIDENCE] ADDRESS WHERE HE IS DULY REGISTERED 17 AND ENROLLED, GIVING CITY, BOROUGH OR TOWNSHIP, WITH STREET AND 18 NUMBER, IF ANY, AND SHALL ALSO ADD THE DATE OF SIGNING, 19 EXPRESSED IN WORDS OR NUMBERS: PROVIDED, HOWEVER, THAT IF SAID POLITICAL DISTRICT NAMED IN THE PAPERS LIES WHOLLY WITHIN ANY 20 CITY, BOROUGH OR TOWNSHIP, OR IS COEXTENSIVE WITH SAME, IT SHALL 21 NOT BE NECESSARY FOR ANY SIGNER OF A PAPER TO STATE THEREIN THE 22 23 CITY, BOROUGH OR TOWNSHIP OF HIS RESIDENCE. NO ELECTOR SHALL 24 SIGN MORE THAN ONE NOMINATION PAPER FOR EACH OFFICE TO BE 25 FILLED, UNLESS THERE ARE TWO OR MORE PERSONS TO BE ELECTED TO 26 THE SAME OFFICE, IN WHICH CASE HE MAY SIGN NOMINATION PAPERS FOR AS MANY CANDIDATES FOR SUCH OFFICE AS, AND NO MORE THAN, HE 27 28 COULD VOTE FOR AT THE SUCCEEDING ELECTION. MORE THAN ONE 29 CANDIDATE MAY BE NOMINATED BY ONE NOMINATION PAPER AND 30 CANDIDATES FOR MORE THAN ONE OFFICE MAY BE NOMINATED BY ONE 20170HB0444PN2589 - 5 -

NOMINATION PAPER: PROVIDED, THAT EACH POLITICAL BODY NOMINATING
 DOES NOT NOMINATE MORE CANDIDATES THAN THERE ARE OFFICES TO BE
 VOTED FOR AT THE ENSUING ELECTION: AND PROVIDED, THAT ALL THE
 SIGNERS ON EACH NOMINATION PAPER ARE QUALIFIED TO VOTE FOR ALL
 THE CANDIDATES NOMINATED THEREIN.
