AN ACT

- 1 Establishing the Results First Project; and providing for data 2 collection and analysis by the Independent Fiscal Office.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Results First
- 7 Act.
- 8 Section 2. Legislative intent and purpose.
- 9 The General Assembly finds and declares as follows:
- 10 (1) A nationally recognized cost-benefit analysis model
- 11 will allow the General Assembly to direct public resources to
- 12 cost-effective programs that deliver the best outcomes for
- 13 residents.
- 14 (2) The Independent Fiscal Office shall receive periodic
- updates that incorporate new research and enhancements
- 16 identified through work in participating states and practical
- 17 technical assistance to implement this cutting-edge approach

- for identifying policy and budget options.
- 2 (3) Through this effort, Pennsylvania will lay the
- 3 groundwork for a strong evidence-based approach that will
- 4 identify the State government's vision, mission, philosophy,
- 5 priority goals and benchmarks.
- 6 (4) The General Assembly will help State agencies to
- 7 align the State agency's individual efforts and resources to
- 8 achieve Statewide priority outcomes.
- 9 Section 3. Definitions.
- The following words and phrases when used in this act shall
- 11 have the meanings given to them in this section unless the
- 12 context clearly indicates otherwise:
- "Data source." Any of the following:
- 14 (1) An office, department, authority, board, multistate
- agency or commission of the executive branch or an
- 16 independent agency.
- 17 (2) The Office of Attorney General.
- 18 (3) The Department of the Auditor General.
- 19 (4) The Treasury Department.
- 20 (5) A judicial agency.
- 21 (6) A legislative agency.
- 22 (7) The Pennsylvania Health Care Cost Containment
- 23 Council.
- "Independent agency." The following:
- 25 (1) The Pennsylvania Public Utility Commission.
- 26 (2) The Pennsylvania Fish and Boat Commission.
- 27 (3) The Pennsylvania Game Commission.
- 28 (4) The Pennsylvania Historical and Museum Commission.
- 29 (5) The State Civil Service Commission.
- 30 (6) The Pennsylvania Turnpike Commission.

- 1 (7) The Milk Marketing Board.
- 2 (8) The Pennsylvania Liquor Control Board.
- 3 (9) The Pennsylvania Human Relations Commission.

- 1 "Pennsylvania Results First Project." A multidimensional
- 2 data analyzing system.
- 3 Section 4. Duties.
- 4 (a) Development. -- Within one year of the effective date of
- 5 this section, the Independent Fiscal Office shall implement and
- 6 maintain the Pennsylvania Results First Project.
- 7 (b) Consultation. -- The Independent Fiscal Office shall
- 8 consult with a nationally recognized organization that
- 9 specializes in and has expertise with the scientific basis of a
- 10 cost-benefit analysis model.
- 11 (c) Reporting. -- The Independent Fiscal Office shall provide
- 12 reports as directed by the General Assembly by joint resolution.
- 13 Section 5. Data.
- 14 (a) Collection. -- Subject to any applicable limitation
- 15 provided by law, a data source shall submit, upon request of the
- 16 Independent Fiscal Office, data required for use as provided by
- 17 this act.
- 18 (b) Duty.--
- 19 (1) Data sources identified by the Independent Fiscal
- Office shall comply with the criteria established by the
- 21 Independent Fiscal Office and satisfy requirements deemed
- 22 necessary by the Independent Fiscal Office in order to
- 23 provide data.
- 24 (2) The Independent Fiscal Office shall work
- 25 collaboratively with data sources as necessary to ensure that
- 26 the data provided is of appropriate content and conforms to
- 27 practicable format specifications. Data requirements of the
- 28 Independent Fiscal Office shall take into account work flow
- 29 requirements of data sources.
- 30 (c) Results.--A data source may not be charged a fee to

- 1 receive the results generated from data submitted by the data
- 2 source under this section.
- 3 Section 6. Effective date.
- 4 This act shall take effect immediately.
